INVESTMENT OBJECTIVE

The balance will be composed of fixed income and/or cash at the investment manager's discretion. The risk profile of this strategy is Medium/High. The choice of investments will not be limited by geographical area, economic sector or currency and investments are made with no reference to a market index. The Compartment is likely to hold 25-40 equities at any given time. The criteria for the Compartment's investable base of companies include:
